The appointment of the officials mentioned as above has been made on temporary basis for the present and confirmation in the post is subject to the satisfactory completion of the period of probation i.e. 02 years from the date of appointment and they will be governed by ESI Corporation (Staff and Conditions of Service) Regulation 2023, (as amended) and other terms and conditions laid down in the Offer of Appointment Memorandum issued to them.

The above mentioned officials have been medically examined by the Medical Board and found fit for service under Employees' State Insurance Corporation.

Their appointment is provisional and is subject to verification of the Character & Antecedents, educational qualification, caste certificates and other information being verified through the proper channels and if the verification reveals that the information/ certificates provided by the officials is false, the service will be terminated forthwith without assigning any further reasons and without prejudice to such action as may be taken under the provisions of the Bhartiya Nyaya Sanhita for production of false information.
